TERMS AND CONDITIONS

- Whilst every care is taken of the dogs undergoing treatment and in the maintenance of the water and equipment, all dogs receive hydrotherapy/physiotherapy entirely at their owners risk.
- 2. All treatment courses including those to be part of an insurance claim, must be paid for in advance. Individual sessions must be paid for at the time of the treatment session.
- 3. Session fees will be charged in full if an appointment is broken or cancelled without 24 hours notice.
- 4. Dogs will not be treated without the prior authorisation of their veterinary surgeon.
- 5. Dogs with contagious or infectious conditions such as, ear, eye or skin infections cannot be treated. Dogs with diarrhea or vomiting cannot be treated. Owners are advised to cancel their appointments within 24 hours notice until the condition is clear. Dogs will not be treated without up to date vaccinations.
- 6. Bitches in season will not be able to attend sessions until their season has finished.
- 7. Owners are required to notify Aquatread Canine Hydrotherapy if, during course of treatment, the dog's injury or condition worsens, or if the veterinary surgeon advises that the treatment is to be stopped or suspended.
- 8. Aquatread Canine Hydrotherapy reserves the right to refuse treatment to any dog.
- 9. Owners are requested not to bring dogs other than those been treated to the facility.
- 10. Owners are requested not to feed their dog for at least 3 hours before attending an appointment and to ensure that their dog has had the opportunity to toilet prior to arriving.
- 11. When not undergoing treatment all dogs must be kept under control and must be on a lead with exception to those that are unable to walk unaided.
- 12. It is the owner responsibility to pick up after their dog whilst on the premises and in the surrounding area. Poo bags are available at the facility.
- 13. Aquatread Canine Hydrotherapy cannot be held responsible for any loss or damage to vehicles or personal property whilst on the premises.
- 14. Aquatread reserves the right to use video footage and photographic stills taken during sessions.
- 15. Aquatread Canine Hydrotherapy centre is not the ideal environment for young children. Should it be necessary for owners to bring children, in the interests of health and safety they must remain supervised by the accompanying adult at all times.
